Florida Concealed Weapon or Firearm License Course

3-hours basic firearms (NRA First Steps)
1-hour Florida Statute
2-hour Range

The State of Florida requires a basic firearms course to satisfy the education requirements of the Florida Concealed Weapon or Firearm License under Florida Statute 790.006.

The Raven Agency LLC (TRA) offers a six (6) hour course that satisfies the criteria under FS 760.006 (h.) for a demonstration of competency with a firearm.

All of our instructors are certified NRA Instructors, Florida "K" License holders or Law Enforcement Firearms Instructors.

Concealed carry training is covered in a four (4) hour classroom and a two (2) hour range session.

The course includes:

- (1.) An overview of Florida's concealed carry application.
- (2.) Basic handling, safety and storage procedures for firearms.
- (3.) Concealed carry methods, and firearms maintenance and care.
- (4.) Fundamentals of shooting and handgun operation including live fire.
- (5.) Florida applicable State laws including 790 and 776, use of force.
- (5.) A Certificate of Completion of the NRA First Steps Pistol Orientation course which will satisfy the education requirement of the Florida application.

TRA does not issue "store" or "school" certificates. All certificates are for registered NRA courses and listed on the NRA training website for verification if needed. The cost of the NRA materials is included in the course fee.

Please check the TRA calendar located on the bottom of the TRAINING page of TRA website for scheduled classes or call for special class times.

Additional class times or multiple student discounts can also be arranged. Please call TRA to discuss any special needs or requirements.

Prerequisites: NONE – Open to the Public

Licensing Requirements:

- (1.) Must be 21 years of age,
- (2.) Have no disqualifying criminal history. (A background check will be run as part of the application by the Division of Licensing.)

BEFORE registering for a class and take the Division of Licensing **Concealed Weapon or Firearm License Preliminary Eligibility Determination** questionnaire.

When finished PRINT THE COMPLETED QUESTIONNAIRE, sign and date it on the bottom and bring it with you to the class.

Cost: \$150.00 plus Florida Sales Tax.

TRA will provide:

- (1.) NRA appropriate course material.
- (2.) Training firearm
- (3.) Range headset and protective glasses
- (4.) Ammunition necessary to meet the state requirements. (with the current severe shortage of ammunition TRA reserves the right to add an ammunition surcharge. You will be advised at the time of registration.

If you have a firearm that you wish to use for the class please bring it UNLOADED and encased in a closed box or cover. It must be checked by the instructor before being used in the class.

DO NOT BRING ANY LIVE AMMO to the class.

Range sessions are conducted rain or shine. Please wear CLOSED SHOES and bring appropriate jackets, etc., for the expected weather. If you wish to wear your prescription glasses please bring a brimmed (baseball type) hat.

(TRA accepts cash, credit cards (MC, VISA, AMX) or company checks. (Sorry no personal checks or money orders.)
